



## Door Access System

• DOOR ACCESS CONTROL

Advatek Systems provides **TT/Access**, a door access control system that gives you control over who enters the premises.

It's an automated system preventing unauthorized persons from getting in while allowing employees to come and go as required. With the system in place employees pass their badge by the door scanner, and if privileges permit, the door is unlocked.

Each time the card is used the event is recorded, thereby creating a history of *who, when & where* that can be examined by administrators. If an employee quits, or attempts to enter at inappropriate times or locations, access is refused and the fact is logged in an exception report.

**TT/Access** can be used alone, or as part of a comprehensive labour tracking

solution **TimeTek**, that tracks time for payroll as well as providing job function costing to better manage manpower expense.

The advantage here is the door controllers and time clocks accept the same cards/badges, avoiding the expense and hassle of managing two different sets of badges. Software setup is easier too because the employees are already entered in the **Timetek** system.

There are 3 parts included with a **TT/Access** system:

1. **Door controller** for each door to be covered.
2. **New or existing server PC** with **TT/Access** software loaded.
3. **Access badges** (**TimeTek** cards will be used).

Advatek Systems will install these components, connect them to the computer network, train the staff, and provide remote support afterwards.



Please note that more is required to finalize the door access system.

Advatek Systems does not provide or install the following;

- Door(s) and required electronic door locking mechanism. Electronic locks come in two types, *strikes* and *magnetic locks*. Mag locks require more hardware to satisfy safety regulations. You should consult with a locksmith regarding your options.
- 120 VAC power at the location of the door controllers.
- Computer network, network cables or conduit if desired.

During installation maintenance personnel is required to be present to perform any work required for mounting, such as drilling.

Supplies and installation times here are estimates only. Exact amounts will depend on the specifics of the job and the environment in which the system is installed.

Please check with your local fire service to ensure that all proper safety measures are followed.

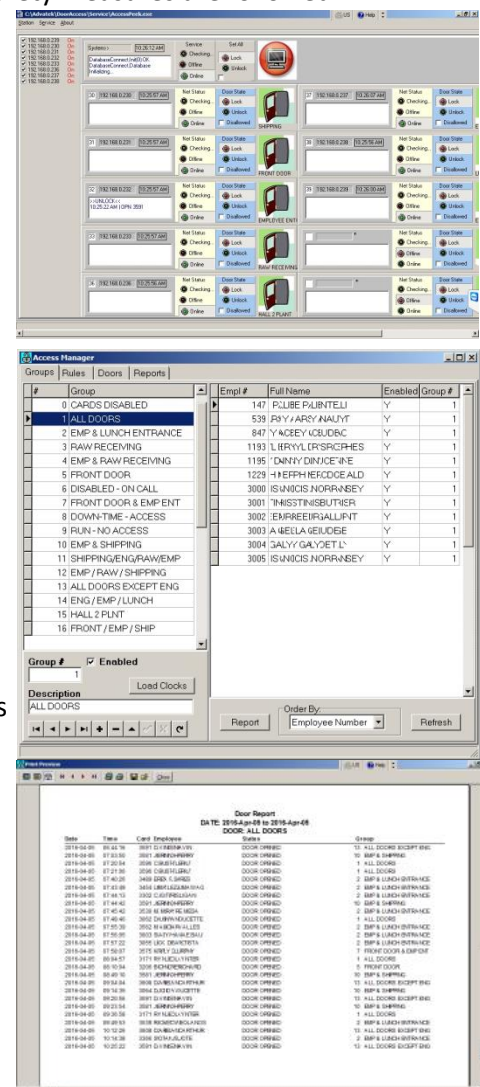

Temporary Open bypass \$125.00 CAD each

- ✓ Normally only needed if a Mag Lock is installed
